- **Scope of Work**: The comprehensive scope of work is reconstruction of the existing building of Ambassador Residence, located at Sarecka 1540/7, Dejvice, Prague 6 (Site Nos. 3129 & 3130), which shall include all activities in accordance of the project documentation for completion of the building.
- **3.** <u>Conditions of Eligibility:</u> General Supplier fulfilling the following conditions of eligibility and submitting the relevant documentary proof therein may only apply:
  - (a) Must have an ability perform the demanding building reconstructions as well as Project Management capability, registered with competent local authorities/professional bodies for carrying out Consultancy services of this nature. A copy of such registration must be enclosed as **Exhibit-1**.

- (b) Must have minimum 07 years experience in the profession. Certified copy of the registration certificate showing registration number, date of registration and its date of validity must be enclosed as **Exhibit-2**.
- (c) The applicant should have successfully completed or substantially completed similar works during last 7 years ending last date of the month previous to the one in which applicants are invited as per either of the following
  - i) Three similar works completed- each costing not less than the amount equal to CZK 30,000,000/ (Czech Koruna Thirty Million).

or

i) two similar works completed-each costing not less than amount equal to CZK 36,000,000/ (Czech Koruna Thirty Six Million).

Or

- i) one similar work completed-and costing not less than amount equal to CZK 58,000,000/ (Czech Koruna Fifty Eight Million).
- ii) Any foreign potential contractor must prove of experience in the execution of at least two heritage reconstructions abroad and one in the Czech Republic (Prague) as well, English as condition.
- iii) the project manager and the main construction manager shall be full time employee of contractor
- iv) project manager or main construction manager has at least 10 years of experience in monumental reconstruction in the Czech Republic, Prague
- v) all documentation and communication between client and contractor on site shall be in English
- (d) Copy of award letter and completion certificate for each such work must be enclosed as **Exhibit-3**.
- (e) Should have had annual turnover of CZK 36,000,000/- (excl. VAT) or more on construction works during immediate last three consecutive financial years. This should be duly audited/certified by a Chartered Accountant as **Exhibit-4**.
- (f) The firm must not have suffered loss in more than two of the last immediate five years from the current financial year and must not have suffered loss in the immediate preceding financial year. Must submit balance-sheet for last 5 years as **Exhibit-5**.
- (g) Should have sufficient number of Technical & Administrative Employees for rendering the consultancy services.

- (h) Bank Solvency: The applicant should submit certificate of solvency for CZK 30,000,000/- or more certified by the bank. The certificate should not be older than a month and it is required to be renewed periodically every six months as **Exhibit-6**
- (i) Additional information pertaining to association arrangement, if applicable, with other technical firms/professionals, commitment regarding adherence to professional Code of Ethics, liabilities, etc. may be submitted along with the application as **Misc. Exhibit**

### 4. Payment terms and conditions

- (a) General Supplier shall be entitled for payment by the conditions mentioned in **draft agreement** about a contract (enclosed along with the RFP). This payment shall be excluding VAT, taxes, etc.
- (b) **Retention Money/Security Deposit**: 10% of the price shall be held back from each payment, as Retention Money. Half of this 5% of the Consultancy fee shall be released after one month of issue of completion certificate to the Contractor and remaining Half shall be released after one year from that date.
- (c) <u>Currency</u>: the currency of payment shall be Czech Koruna (CZK).

#### 5. Time Schedule

- (a) The work shall be carried out by the General Supplier with due expedition and in accordance with the time schedule.
- (b) The time schedule of **18 months** shall be deemed to be the essence of the contract on the part of the General Supplier.

#### 6. Suspension

- (a) The **Embassy of India, Prague** may suspend all or part of the services by giving a notice to General Supplier and General Supplier shall immediately make arrangement to stop the services and shall not make any further expenditure from his end.
- (b) On suspension of the General Supplier's appointment, the General Supplier shall be entitled to fees for all completed stages of work at that time.
- (c) On the resumption of suspended service within six months, previous payments shall be regarded solely as payments on account towards the fees. No claim for additional fees on any account would be entertained.

#### 7. FORCE MAJEURE

- a) In the event that either party is prevented wholly or in part, by any force majeure cause, as defined hereinafter from performing or accepting performance by the other party, this party should give without delay a written notice to the other party and the parties will either agree to a fresh completion date by condoning the period of delay arising out of such non-performance or may by mutual consent, treat the contract as terminated. However, if the force majeure conditions persist for an unreasonably long time, the party not under force majeure conditions may, by giving a notice to the other party, terminate the contract. In either case of termination, both parties will have no claim for compensation against each other, but shall receive their dues as prevailing on the date of commencement of force majeure conditions. Force Majeure is herein defined as:
  - i) Any cause which is beyond the reasonable control of the Consultant or Employer.
  - ii) Natural phenomena including but not limited to weather conditions, fire, explosion, flood, drought, earthquake and epidemic.
  - iii) Acts of any Governmental authority, domestic or foreign, including but not limited to war declared or undeclared, priorities, guarantees, endangers, licensing controls or production or distribution restrictions;
  - iv) Disruption in communication;
  - v) Strikes and lockouts;
  - vi) Sabotage, riot, civil commotion, invasion and insurrection.

#### 8. ARBITRATION

- a) In the event of any dispute or difference arising at any time between the parties relating to the construction; meaning or effect of this Agreement or any other cause or any content of the rights and liabilities of the parties or other matters specified herein or with reference to anything arising out of or incidental to this Agreement or otherwise in relation to the terms; whether during the continuance of this Agreement or thereafter, such disputes or differences shall be endeavored to be solved by mutual negotiations.
- b) If, however, such negotiations are infructuous, Arbitration shall be carried out as per provisions of UNCITRAL (United Nations Commission on International Trade Laws). The venue of arbitration shall be Prague, Czech Republic.
- c) Any reference to arbitration shall not relieve either party from the due performance of its obligations under this Agreement.

## 9. TERMINATION

a) Under overall circumstances, if the Employer terminates the Agreement either in whole or portion thereof, General Supplier shall be compensated for the services carried out till the date of termination, less any disputed amount. The Employer shall discuss in detail with General Supplier to exhaust all possibilities of General Supplier not being able to deliver its services before applying the termination clause.

# 10. DEFECT LIABILITY PERIOD

a) The General Supplier shall be liable for any defect during the defect liability period of 1 year.
